### 4. Safety Shoes

MSC - Agreed that employees should not have to take off shoes to show ANSI label. Original receipts are needed by Payroll for auditors. (If employees want to keep original, they should bring the receipt in and then a copy will be made for our records).

### 5. Hot Meals

## MSC -Will research:

a. Which local restaurants will deliver and under what restrictions.

- b. How and when hot meals can be provided if restaurants will not deliver.
- c. Employees are not required to take a meal ticket or a frozen dinner in lieu of a hot meal unless a hot meal cannot reasonably be provided.

# 6. Call Time for Summer Employees

- Discussed past practice and intent of language regarding Call Time pay to college pool employees.
- USC Contends that calltimes have been paid for many years and was not intended to be excluded for summer employees and request MSC to reconsider.
